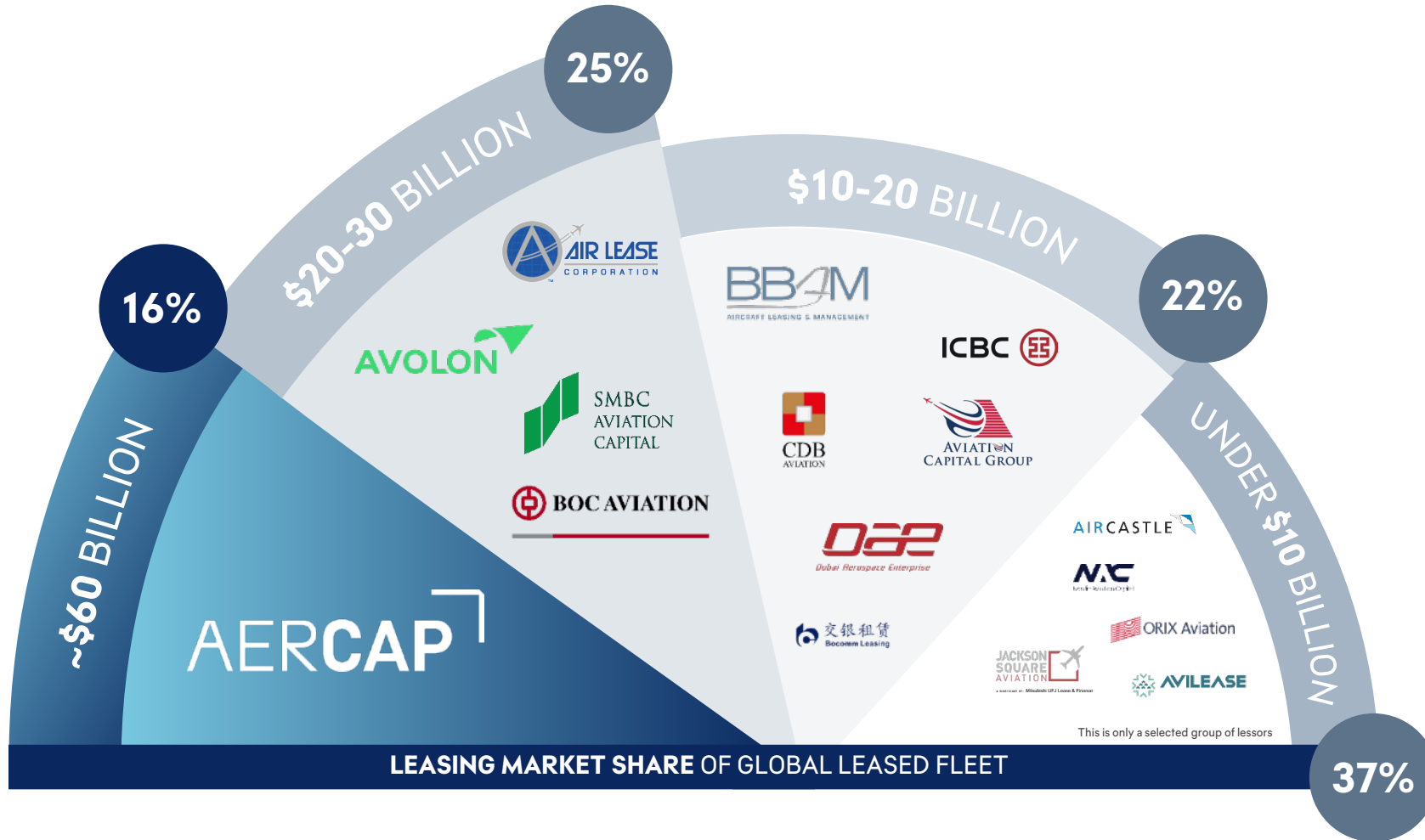

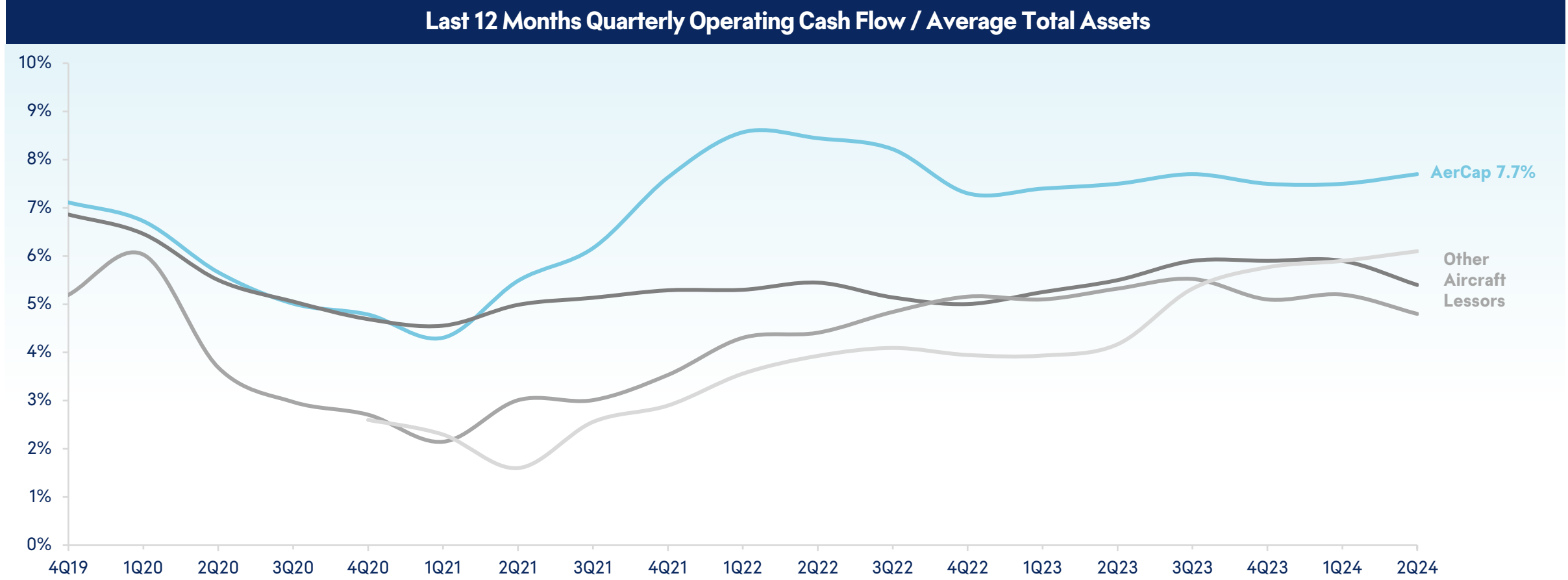

BEST-IN-CLASS OPERATING CASH FLOW

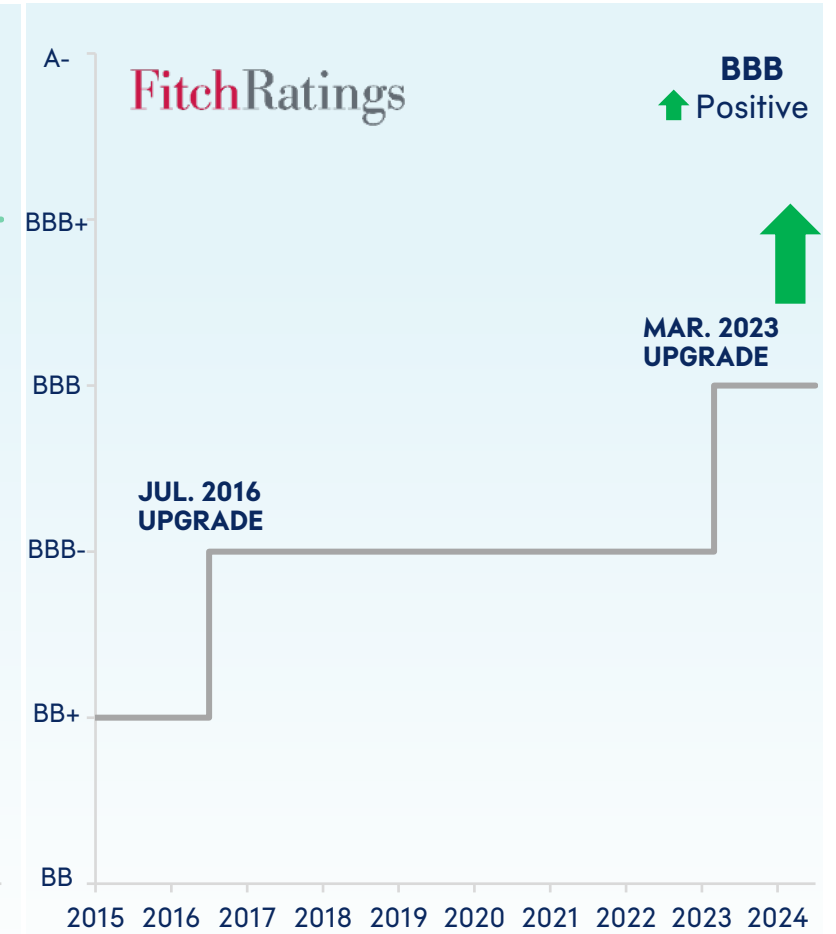
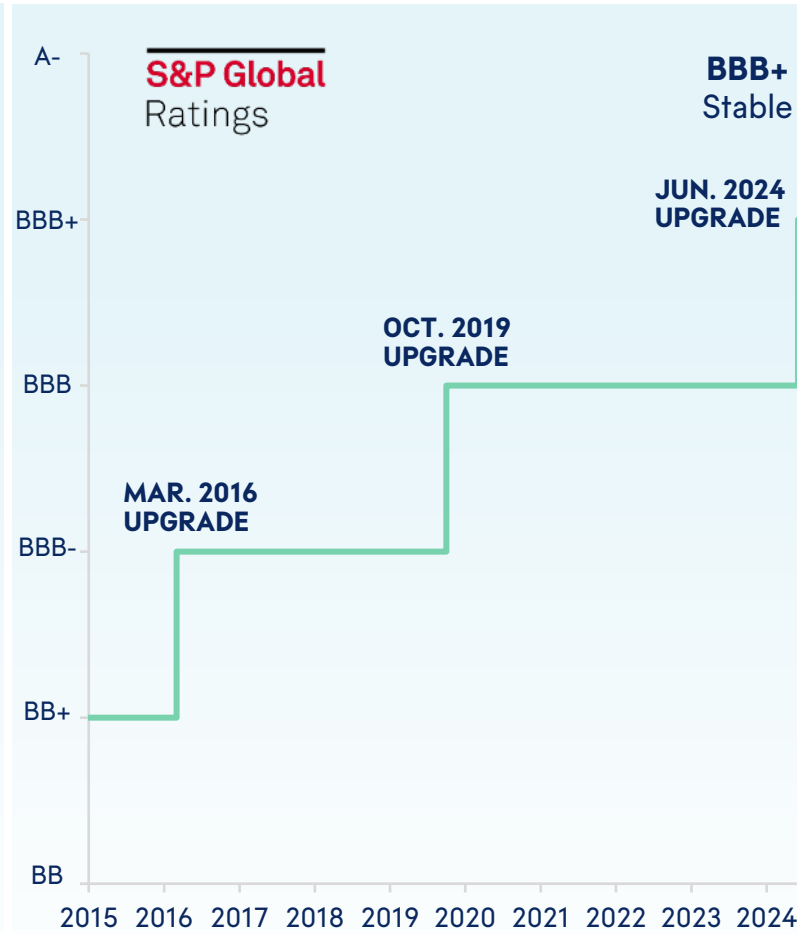
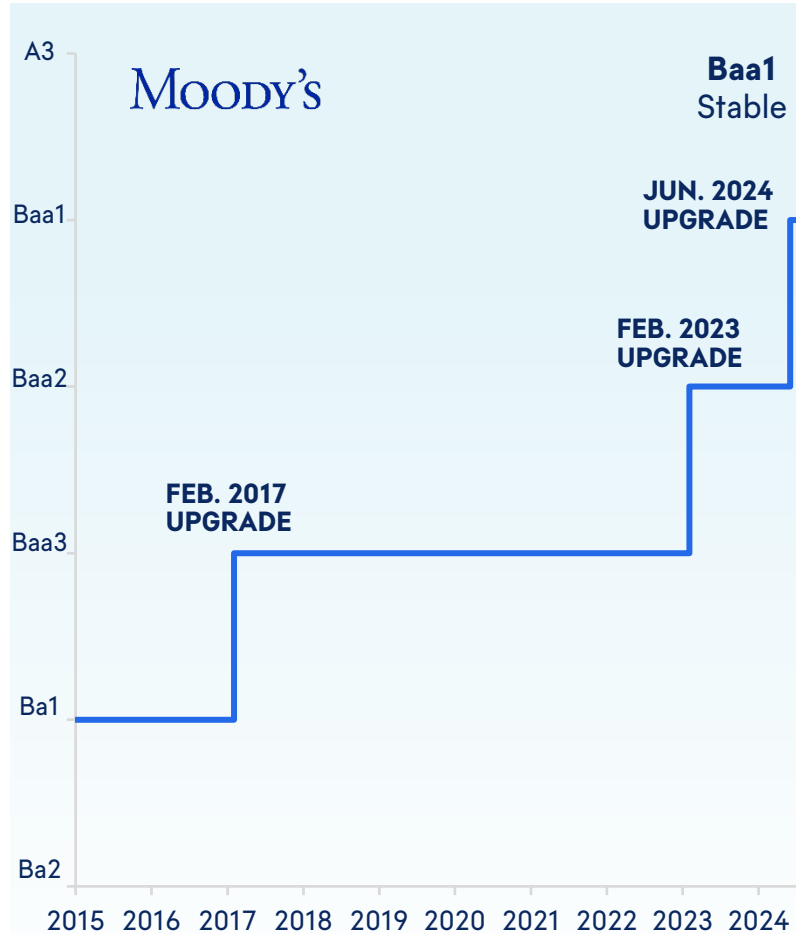
AerCap is outperforming other aircraft lessors by a wide margin
